**Please note:**

**Equine influenza:**

All horses must have documentation, endorsed by a veterinarian, or an initial series of two intramuscular injections for primary vaccination against equine influenza given no less than 21 days and no more than 92 days apart. In addition, a booster injection must be recorded as having been given at least within every 12 months following the 2nd shot of the initial series.

**Exhibition and transport:**

Owners are responsible for knowing and meeting ant health requirements regarding the exhibition of horses and their transport between their home location and the show. Please check with your local veterinarian.

**Conduct:**  
Cruelty, abuse or inhumane treatment of any horse in the show ring , barn, stalls, or on the show grounds is strictly prohibited. The use of stimulants or depressants or any drug affecting the showing of a horse is forbidden.

**Responsibility:**  
Participation is at one's own risk. The show management cannot be held responsible for any accidents, damages, or loss to personal property or livestock.

**Refunds:**  
Refunds will not be given without a veterinarian's written certificate stating why the horse is unable to show (illness or injury). Substitutions will be accepted without penalty.
